2. **CHECK-IN / OUT TIMES:**
Arrival time: 14h00
Departure time: 11h00
If a client wishes to check-in or check-out other than the allocated times, it must be arranged with the Reservation Office. (R150.00 per hour if no other guests to arrive on the same day).
PLEASE NOTE:
* No more persons than beds.
* Do not move the furniture, bedding or mattresses from the original place.
* On departure make sure all the cutlery / utensils etc is in place.
* **UNIT DEPOSIT: (CASH ONLY ACCEPTED)** R 100.00 on caravan stands with private ablutions / R300.00 on chalets and tent houses
* **Keys must be handed in BEFORE 11:00:00 at the Reception Office on the day of departure.**
Unfortunately you will be charged:
* If your key is not handed in before 11h00 on the day of departure.
* If the dishes / cutlery were not washed and put in place on departure or moved from one chalet to another.
3. **PAYMENT OPTIONS: (See page 2 for all payment information)**
* EFT payment 48 hours from booking.
* Bank details are on your Booking Confirmation with your Booking number.
4. **CANCELLATION POLICY:**
In case of cancellation please note our cancellation conditions and fees:
a) 2 weeks before *out of season* and *midweek season* - 25% of total amount forfeited
b) 30 days before for June holidays - 25% of total amount forfeited.
c) 30 days before any event weekend - 25% of total amount forfeited
d) Not after 10th February for March/ April/ May season - 25% of total amount forfeited.
e) Not after 10th October for December / January season - 25 % of total amount forfeited.
f) Not later than 60 days before any long weekend or public holiday - 25% of total amount forfeited.
g) **Less days than specified above, a 100% of total amount will be forfeited.**
It is highly recommended that all guests take out comprehensive travel insurance including medical cover, as well as cancellation and curtailment cover.
5. **CLIMATE:**
Summer (October to March). Rainy season, hot days, warm nights. Temperature usually 25-35 degrees cent.
Winter (April - September). Dry season, generally warm days, cold nights. Temperature usually 10 - 25 degrees cent.
6. **GATE TIMES:**
Main Camp Gate : 8h00 - 22h00.
Main Gate: 24/7
7. **PAYMENTS:**
1. **Payments to be made within 48 hours from booking.** The system cancels automatically when no payments show on the Reservation / Booking number.
2. **Full payment on all bookings within 48 hours.**
3. 50% Deposit required for the December High Season only if the booking is longer than 7 days.
4. For 6 and less days booked during the December High Season a FULL payment must be made within 48 hours.
5. **December bookings that only a 50% deposit was paid, the BALANCE is payable 30 days prior to stay.**
6. Bookings made less than 30 days before arrival the FULL amount to be paid within 24 hours.
7. Bookings will be cancelled automatically by the system if payments were not received with the correct reference number, the correct amount or on time. (Note that the Reception staff does not have control over the cancellations and no alternative arrangements can be made.)
8. Only EFT payments / direct banking accepted on accommodation.
9. No payments for accommodation will be accepted at the Reception counter except when the booking is made the same day and there is no other alternative.
10. Proof of payment to be mailed to booking1@mbizi.co.za
11. When paying via EFT with foreign currencies, note that all bank charges are for your account.
12. Ensure that you utilize the 11 digit Booking Reservation Number as your reference.
13. If payment does not reflect on the bank statement within 48 hours, Camiblox (Pty) Ltd (Pty) t/a Mbizi Lodge has the right to automatically release reservations being held for.
14. Mbizi Caravan Lodge (Pty) Ltd cannot guarantee that the same Stand / Chalet or number of units will be available to re-instate where bookings have been cancelled due to non-payment or incorrect payments.
15. Wrong payments will not be allocated to the reservation.
16. Mbizi Caravan Lodge (Pty) Ltd does not accept any payments for accommodation on arrival.
8. **GROUP BOOKINGS:**
The person who made the booking is responsible for the full payment at least 30 days prior to arrival.
The group will not be allowed to put up camp / get access to unit if the full payment is not received and proof delivered

- 9 **REFUNDS AND TRANSFER POLICY:**
1. No refunds or changes for any late arrivals or early departures.
 2. No refunds for short notice cancellations (Refer cancellation policy on page 2, no 4)
 3. No refunds or changes for persons who did not arrive with group / or on the stand.
 4. The person who made the booking (individual and group bookings) is still responsible for all the payments.
 5. Changes, cancellations or bank details must be given in writing.
 6. These conditions also apply for bookings made AFTER the deadlines given on page 2, no 4
- 10 **TRANSFERS OF MONEY/ BOOKINGS:**
No transfer of money or bookings to another date or stand.
It is highly recommended that all guests take out comprehensive travel insurance including medical cover, as well as cancellation and curtailment cover.
- 11 **RATES APPLY:**
For 1 Caravan:, 4 persons per site & 1 vehicle - however max of 6 people at extra costs regardless of age. (Babies and pensioners are also counted as a person)
Chalet: Rate for 1 vehicle included and no more persons than beds per chalet. A BABY IS ALSO A PERSON. Rates may change without prior notice.
- 12 **CARAVAN:**
1. Any caravan, trailer with camp facilities, vehicles with camp facilities, roof tent vehicles and tents will be classified as a caravan. If you camp with for example a 4x4 trailer, you need to book a stand per trailer (no "double ups" will be allowed).
 2. All stands are pre booked.
 3. Please report @ reception before setting up camp.
 4. Management have the right to transfer stands without prior notice.
 5. Extra tents only on prior arrangement.
 6. Groundsheets - NO SOLID sheets, only open weaved groundsheets allowed.
 7. 15 amp electrical points at caravan sites *excluding those sites in the Bush Camp*).
 8. Blue plugs also available in the shop.
 - 9 Note that the **Bush Camp** does not have electricity. The ablution is operated on solar panels. Hot water is sometimes a bonus. This camp is also rated as an "eco friendly" camp and suited for guests who prefer to get away from the every day luxury.
 10. **Wildskamp:** This camp was developed during 2011 and is approximately 200m from the main camp's gate. The ablutions are operated by solar systems and eco friendly.
- 13 **ABLUTIONS:**
1. **No children under 10 years without adult supervision.**
 2. No children without adult supervision allowed in the Family Bathrooms.
 3. SHARED ABLUTIONS are cleaned on a regular basis, however to leave the ablution as one would like to find it, it is CAMP ETIQUETTE.
 4. **PRIVATE ABLUTIONS:** Private bathroom stands (to be cleaned by visitor, however will be cleaned by Mbizi staff Before your arrival). Not serviced during ordinary weekends and weekdays and only every third day during High Season. The private ablution will only be serviced when an adult of the stand is present.
- 14 **WEEKENDS:**
1. Cannot be split. The customer pays for the Friday and Saturday night.
 2. The same rule applies for Long weekends/ Public Holidays/ School Holidays where compulsory nights are given.
- 15 **UNIT DEPOSIT:**
1. A refundable unit deposit of R100 (private ablution stands) and R300 (chalets and tent houses) is payable in **CASH** and will be re-funded on day of departure before 11h00 if there are no losses or breakages.
 2. Please note that no refunds will be given to children under the age of 18.
 3. **We do not accept cheques or EFT's - only CASH! (No card facilities).**
- 16 **CHALETS:**
1. Equipped with cutlery, crockery and linen.
 2. Towels not supplied.
 3. Mountain chalets have TVs (certain DSTV channels).
 4. Serviced daily - floor and bath cleaning and bed making - **NO DISHWASHING.**
 5. At least a 2x4 vehicle required for entry to the Mountain chalets.
 6. **The chalet must be evacuated BEFORE 11h00 of the day of departure and remember to hand in your key.** Your unit deposit will be used if your dishes are not washed on departure.

- 17 **VISITORS:**
1. Visitors and extra vehicles at extra cost (Max of 6 persons/ site).
 2. Make prior arrangements at the office for your guests please
 3. Visitors of our guests must arrive no later than 12H00 and leave before 18h00.
 4. Report at Reception on arrival.
- 18 **PETS:**
1. No dogs or cats.
 2. A fine of R500.00 per animal per day.
- 19 **NO** rollerblades, skateboards, Scooters, bicycles in front of shop and restaurant, at pool area, in ablutions, on trampolines or putt-putt.
- 20 **SILENCE:**
1. **No noise after 22h00.**
 2. At all times, music, radios, TVs must be played so that only you can hear them.
 3. Only music organized by management may be played in public areas.
 4. Please feel free to contact the Manager on Duty if you have any problems with noisy campers/ guests after 22h00 and before 07h00.
 5. Contact details will be on the door at Reception.
- 21 **SPEED LIMIT:**
1. 20 km/h.
 2. Dead slow in camp.
 3. Children have right of way.
- 22 **NO** motorcycles, battery powered bikes or quad bikes are allowed.
- 23 **GAME VIEWING:**
1. No private game viewing in own vehicles.
 2. R1000.00 fine per vehicle.
 3. PLEASE TAKE NOTE that you are allowed to cycle or walk on the farm.
- 24 **FIRES:**
1. May only be made in the braaiers that are available at stand/ chalet.
 2. Gathering of wood is prohibited.
 3. Wood is for sale in the shop.
- 25 **SHOP AND OTHER FACILITIES:**
1. No children under 10 years without adult supervision are allowed in the shop.
 2. Bottle store, DSTV in bar/coffee shop and take away (open on weekends, long weekends and public school holidays),
 3. ATM machine available - no card facilities,
 4. Small laundry, jungle gym, pool tables, volley ball (bring your own ball), putt-putt, hiking trail, trampolines, farmyard, cold and heated swimming pools, Game drives (book in advance at Reception), outdoor Jacuzzi.
- 26 **TRAMPOLINES:**
1. No smoking, eating or drinking.
 2. No shoes on trampolines.
 3. Trampoline times are from 7h30 until 21h00.
- 27 **GATE PASS:**
1. Report at RECEPTION ON ARRIVAL
 2. Your gate pass need to be stamped at the office in order to be able to leave the premises.
 3. R50.00 fee will be charged for a lost gate pass.
 4. Make sure your gate pass is stamped *during Office Hours*.
 5. Unfortunately we do get guests that do not report on arrival and try to get of the premises late on the day of arrival. Please note, that you will not be allowed to leave the premises without the stamped gate pass. It may take time for the our staff to get to the Reception Office.
- 28 **ANIMALS:**
1. Wild animals are dangerous, please don't touch or feed.
 2. Facilities are used at own risk.
- 29 **MBIZI FLIGHT CLUB:**
1. Managed by a qualified pilot. Mbizi Lodge doesn't take responsibility for any injuries, death or damage which may result of utilizing the facility.

- 30 **FALSE INFORMATION:**
1. **Camiblox** (Pty) Ltd t/a Mbizi Lodge will not be held responsible for any information given by any other company, web sites, travel agencies, person etc that is incorrect.
2. No claims will be considered where clients received the incorrect information from other companies, persons etc.
- 31 **ELECTRICITY:**
The local Bela Bela Municipality provides Mbizi Lodge with electricity. Mbizi cannot be held responsible for power failure due to the Municipality's shortcomings.
- 32 **CHILD POLICY:**
1. Children of all ages are welcome at Mbizi Lodge.
2. Children have the right of way in the camp.
3. Children under 10 years should be supervised by adults in ablutions, Family ablutions and shop.
4. All parents are asked to look after their children
- 33 **DRESS CODE:**
1. Be dressed in appropriate clothes.
2. No topless costumes or g-strings allowed.
3. No underwear as swimming wear and make sure babies/ toddlers are dressed.
4. Naked persons will be asked to leave the premises immediately.
- 34 **No HUBBLY BUBBLIES allowed on the resort .**

FESTIVAL WEEKENDS / kykNET Buite Ekspo:

The following Terms & Conditions are also valid for event weekends:

1. **COMPULSORY NIGHTS:** Compulsory nights will be booked during these seasons. The extra cost for the Expo/Ekspo will be added automatically and is compulsory for clients who make use of accommodation at the Lodge/Resort, **regardless of age.**
2. **VISITORS: No visitors will be allowed.**
